## Auxiliary Legion of Merit Award – 2024

The Auxiliary Legion of Merit (ALOM) is awarded for service comparable to the ADSM but in a duty of lesser, though considerable, responsibility. The Commandant or any Coast Guard Vice Admiral may award the ALOM. All ALOM packages must be submitted through the appropriate Auxiliary chain of leadership to NACO for review and approval. This applies prior to District review and subsequent routing of nominations to Area or Headquarters level.

In general, the ALOM will be awarded to Auxiliarists in leadership positions who have performed such exceptionally meritorious service as to justify the award of the ADSM, except as to degree of merit. Recognized performance must clearly be much higher than expected and have a measurable, positive effect on the Auxiliary across multiple Auxiliary regions or at Auxiliary Area or National level. This should not be interpreted to preclude the award of the ALOM to any Auxiliarist whose acts or services meet the requirements. When the degree of achievement or service rendered, although meritorious, is not sufficient to warrant award of the ALOM, the AMSM should be considered.

She expertly managed the Auxiliary's National Strategic Plan by ensuring extensive collaboration between Auxiliary national program managers and their Coast Guard counterparts to achieve objectives. As Chair of the Auxiliary Onboarding Work Group, she crafted numerous improvements that greatly streamlined Auxiliary enrollment and ensured new members were quickly welcomed and acclimated in Auxiliary missions. She masterfully established two new Auxiliary national directorates focused on investigative and administrative management along with an innovative new archive for Auxiliary documents, reports, and correspondence. Her oversight of the Auxiliary's Diversity Directorate was instrumental to support of the National Commodore's "Inclusion" watchword and yielded the most annual National Commodore's Three-Star Diversity Award nominations. As a direct result of her inspirational leadership and steadfast commitment to organizational excellence. the Auxiliary delivered more than 3.5 million hours of operational and administrative support to Coast Guard missions, performed more than 202,000 vessel examinations and marine dealer visits, and saved over 100 lives and \$11 million in property.
